## Executive Director's Report – 2007 Annual General Meeting March 17, 2008

In 2007, Catholic Family Services provided professional counselling, group programming, in-home support or some combination of these services to members of 1,169 families. The following statistical information will outline for you a type of profile with regard to the families served:

(Please note in the Family Support Services Program 22% of the families served were two (2) parent families and 78% were one (1) parent families.)

The core services of the agency continue to be offered on a fee for service basis. All fees are on a sliding scale and are waived as necessary. In 2007, 46% of clients paid no fee; 9% paid \$25.00 or less per session; 8% paid between \$30.00 and \$65.00 per session with 37% of clients being Employee and Family Assistance Program clients.

Employee and Family Assistance contracts continue to help supplement services to those unable to pay or those paying partial fees. In 2007 the revenue from EFAP counselling was \$12,237.00 compared to \$4,010.00 for other counselling, others being the majority of agency clients.

Fees collected for group programming is minimal. For 2007 revenue was \$1,265.00. Many of our groups are targeted at a vulnerable, high risk population and fees are not charged. We do not attach a cost to children's groups or groups that are funded by an external source.

In 2007 we said goodbye to Children Who Witness Violence Program Facilitator, Adena Melrose and welcomed in the position, Jessica Labman. With the enhanced funding in this program part time staff Karen Carter and Kyle Palmer joined the agency.

In the Family Support Services Program we helped celebrate the retirement of Sheila Bacheldor and hired Shari Wisner, Gloria Winterhalt and Corine Sharp.

In 2007, long time supporters of Catholic Family Services, Mark and Debbie Miller (Marian Press) moved on. On behalf of the agency I would like to extend sincere thanks for all the graphic design and printing they did for us over the years.

I would like to thank the board of directors for your support of the agency and of me in my role as Executive Director. I want to express deep gratitude to the staff. They have a broad skillset, passion for their work and consistently demonstrate professional commitment to the families we serve. Their strong support is critical to the job I do for Catholic Family Services.
